MANAGEMENT

Courts: Resurfacing dates for 1-4 and 9-10 are when?

Courts are beginning to need help!

Grounds: Irrigation still in question. When are we going to finish and get the City to OK and put us in charge.

Clubhouse: Aleta will be patching and painting bathrooms (trim) this month.

Activities: We are to be getting a net from the Patrick Henry HS for court usage. Are our courts too impacted to host Patrick Henry Girls and Boys next year?

Misc.: Cancellation Policy on court reservations. Please see letter submitted by Aron Desai. I will read at board meeting.

Do we need to change our procedure due to overcrowded courts.

As now it the rule reads:

f) In the event that a member cannot play at the reserved court time, the member must notify the Club's staff and cancel the reservations at least 30 minutes prior to the court reservation time. If a member fails to follow this cancellation policy three (3) times, the member's privilege to reserve courts in advance may be revoked, subject to review of the Board of Directors.

SLF ADDENDUM

To best protect a player who has paid their SLF on time, but has become injured and unable to use this feature, I would like to propose the conversion of SLF to Guest Booklet, allowing the nonmember to use the facility on their own time after healing. Further, should that non member be injured after having played only one match of that season, allow them the ability to start over again the following season as a nonmember, though still having to pay the SLF. This has been approved by Management.

CAPTAINS PACKET

Management has found that many captains claim ignorance in regard to rules and procedures which cause a lot of extra work for the staff. We will pilot a Captain's Packet Program to assist in resolving some of these problems.

Management and Leagues will work together to build the packet. Once complete each captain will be required to pick it up in person and sign acknowledging receipt and intention to comply.
