

## **ATTACHMENT TO BOARD MINUTES OF 7/15/09**

The following are reports (condensed) e-mailed to the LMTC Board members prior to 7/15/09 meeting:

### **PREMISES-JUNE 29, 2009**

We are attempting to clean up the areas around the courts and some planting of color before the tournament on July 17. Our 'work Saturday' on July 11 from 7-11 AM promises to be a busy one. And we could certainly use some extra help. Several of us are doing other work around the premises before then.

I want to buy two new hoses, fertilizer and a few plants (although it is getting too hot for most planting). Any problems with that?

We had a rattlesnake on the sidewalk last Thursday morning then the next morning it was in our flowers under the tree by the courts! Something to think about during the tournament.

I have a concern about our water use and need to work with Kathy about that. What do we do with that huge lawn/patch of weeds? The flower bed beyond the lawn/patch of weeds is impenetrable with a shovel.

### **MANAGERS REPORT**

Courts- Since the gates have been bashed in so many times the hinges have weakened and last week we had a break in on court 7 and someone actually took the metal bench! We thought we should try to lock the bench to the fence so this does not happen in the future. Locks are around \$8.00 each times 10 benches is \$80.00. The chains will be an additional cost of around \$100.00. Board will need to discuss and vote.

Grounds- Sprinklers need to be put on and adjusted. And the timer needs to be set to different times. Members complaining in morning when they have to go through sprinklers.

Clubhouse- Aleta Whitaker is in charge of painting exterior of clubhouse July 6,7,8,9th. Rob Pedley washed down the clubhouse before painting.

Activities- Parkinsons tournament will be July 18-19. All courts reserved all day. There will be courts for the teaching pros.

Misc.- Aleta Whitaker came in and said she is not getting emails, mail, etc from the club since submitting her letter. She didn't get her ballot. She wanted this corrected or she said she would sue the club. She said she also talked to Doug about this.

Complaints about Karen Ronney teaching too loudly. We will try to keep her on ct. 9 or 10.

Members complaint- Karen Ronney not returning their calls promptly. Over and over again.

Addition to Manager's Report.

6 women came in to office and complained about Reyna Reyes(Captain- USTA womens team) and how she treats others while being a captain.

One specific complaint reported was how she treated Janet Steinberg after she signed up to be on Reyna's USTA team.

Another separate complaint came in on Reyna being overly aggressive and pushy during a confrontation among players in the parking lot.

And also last month there was another situation that arose with Reyna and a team captain.
