

## MINUTES OF LAKE MURRAY TENNIS CLUB BOARD MEETING

1. **CALL TO ORDER, ESTABLISH QUORUM.** The meeting began at 1:25 p.m. at Lake Murray Tennis Club. There was a quorum.

3. **TREASURER'S REPORT—CONSIDERATION TO ACCEPT FINANCIALS FOR SEPTEMBER, 2014.** Marty distributed the Register Report for 9/1/2014 through 9/30/2014. He said that he has not had to take any money from the money market account recently. He said that the pros money to the Club has increased. However, Karen has not been paying the \$200 requirement.   - D. **Premises. Diane Bailey.** Diane was absent.

All the pros are involved in this event and an e-mail will be sent to the players. **Grossmont Union District Finals.** Doug is in charge of this event which takes place next week Monday through Thursday from 3 to 6 p.m. Tom suggested that we have membership forms there to sign up new members. **San Diego District Yearbook Ad.** The ad that we put in their yearbook is due and costs \$120. **Miscellaneous Payments.** Marty gave Kathy the check for Nathan for the storage unit. Doug needs payment for our domain site. **Protocol for Reserving Courts.** One member can reserve a court, and it is up to the discretion of management if there are any problems regarding court use. A court was reserved for Wright and Wright. Jami Wright was playing in league, so Kathy gave the court away thinking it would not be used. The rule is that, if you are playing league, you cannot reserve a court. It is the One Person Rule. The court was reserved for Wright and Wright. It is believed that there was a misunderstanding about who was to be on the court. **Len Packard.** Len was in a car accident. He is okay but does not have a car. He is going to have Uber bring him to LMTC.
