

LMTC Board Meeting July 24, 2025 1:00 PM

Meeting called to order by new president Tom Handley

Reports:

Treasurer: Income from membership dues is a bit down compared to this time last year, but still on track. Guest passes are also down.

Premises: Mostly fine, no major repairs. Chet said that the locked court gates will remain locked. Due to the hazards (snakes, mud), players are advised against trying to retrieve errant balls

Leagues

- Fall 3.5 Women's League team, captain Amy Snyder

Discussion: Jack asked if league play could start at 9:30 instead of 9 so the courts would be available for doubles from 8 to 9:30. Lynne explained that the times are not set by the clubs but by the leagues

Membership:

- Discussion: Should we be actively trying to recruit new members since we are not close to capacity or would more members just mean fewer available courts? It was confirmed that we can balance the books with the *usual* amount of dues so there's no financial reason to try to greatly increase the membership, but we need to maintain the level of dues playing members. Lynne shared that a number of people join because they want to play in the leagues.

Social:

- Amy suggested that we should have a social media presence and volunteered to look into it. Kathy Emmerson shared that when we had a Facebook page, there were some legal issues around posting photos and other liability problems because of our SUP (Special Use Permit)

Management:

- Court 6 has a new net. Some lights have been replaced, new squeegees are ordered. A new owl will be installed to try to minimize the bird droppings
